7. Handling and storage;

Store at -20°C prior to opening. Thaw at 36°C and combine with melted agar to produce solid media in petri dishes. Store poured plates for up to 6 weeks at 4°C. Avoid breathing vapours, mist or gas.

8. Exposure controls/personal protection;

Use good laboratory practice and wear appropriate PPE; lab coats, eye wear and nitrile gloves.

Eye/face protection Use equipment for eye protection tested and approved under appropriate government standards such as NIOSH (US) or EN 166(EU).

Skin protection Handle with gloves. Gloves must be inspected prior to use. Use proper glove removal technique (without touching glove's outer surface) to avoid skin contact with this product. Dispose of contaminated gloves after use in accordance with applicable laws and good laboratory practices. Wash and dry hands.
